



UPDATED STEP-BY-STEP GUIDE FOR TRAVEL TO THE PHILIPPINES (effective 1 February 2022)

FOR OFWs

Prior to Departure

- Three days before departure**, register your electronic Health Declaration Card (eHDC) through Bureau of Quarantine's [OneHealthPass \(OHP\) Online Registration Platform](#).
 - Save your transaction number** (This is also sent to your e-mail address)
 - OFWs may visit [this link](#) for a step-by-step OneHealthPass guide in Filipino.
 - Every traveller, including children, should each have an OHP Registration.**
- Secure a negative pre-departure RT-PCR test from an MOH-approved [test provider](#), [off-site test provider](#) or [clinic](#) taken **within 48 hours before your flight**.
 - Children below 3 years old (have not turned 3y/o) at the time of arrival are exempted from this requirement*
- Land-based OFWs must register with OWWA's [OFW Assistance Information System \(OASIS\)](#) to facilitate other government support services. Sea-based OFWs must register through <https://ecif.firstaide.ph/>.
- On the **day of your departure**, update your [OneHealthPass/OHP registration](#) with your seat number, health declaration, negative RT-PCR test result and other details.
 - Input your transaction number and last name.
 - Save or print the OHP QR code generated** (This is also sent to your e-mail address)
- Be ready with a print-out of your **digital vaccination certificate from notarise.gov.sg, (with QR Code)** and your negative pre-departure RT-PCR test result. Please visit [this link](#) for more details.



While Inflight: Fill out the Arrival Card, Customs Declaration Form and OWWA Project Care Slip provided by the flight attendant.

Upon Arrival

- Proceed to the One-Stop-Shop Holding Area for a briefing on health and safety protocols.
- For land-based OFWs and dependents, proceed to the OWWA Help Desk after clearing immigration and present the OHP QR code. (Sea-based OFWs and dependents may proceed to the MARINA Desk).
- Claim baggage at the designated area and clear with Customs Check.
- Exit the terminal and wait for the shuttle to your designated/assigned hotel.

FULLY VACCINATED OFWs	UNVACCINATED/PARTIALLY VACCINATED OFWs
Self-monitor for any COVID-19 signs and symptoms for 7 days; no mandatory facility quarantine is required. Any sign or symptom must be reported to the local government unit of destination.	<ol style="list-style-type: none"> Upon arrival at the quarantine hotel, present the OHP QR Code upon check-in. On the 5th day (with Day 1 as arrival date), proceed to the designated RT-PCR testing area and present your OHP QR code. Wait 24-48 hours until the release of your test results. If your post-arrival RT-PCR test result is negative, you will be allowed to check-out of your quarantine facility and spend the remaining days to complete fourteen (14) days of quarantine at home. Present the OHP QR Code upon check-out
<i>Minor travellers below 12 years old (have not turned 12 y/o) who cannot be vaccinated shall follow the quarantine protocols of parent/s or accompanying adult/guardian travelling with them.</i>	



FOR Non-OFWs and FOREIGN NATIONALS

Prior to Departure

- Three days before departure**, register through Bureau of Quarantine's [OneHealthPass \(OHP\) Online Registration Platform](#). **Save your transaction number**. The transaction number will also be sent through your registered e-mail address.
 - Save your transaction number** (This is also sent to your e-mail address)
 - For travellers who do not have an address in the Philippines, you may put your company address or the address you will stay in after your quarantine period in the "permanent residence" field
 - Every traveller, including children, should each have an OHP Registration.
- Secure a negative pre-departure RT-PCR test from an MOH-approved [test provider](#), [off-site test provider](#) or [clinic](#) taken **within 48 hours before your flight**.
 - Children below 3 years old (have not turned 3y/o) at the time of arrival are exempted from this requirement
- For unvaccinated non-OFW/foreign travellers only:** Pre-book a quarantine facility/hotel (QF/QH) of your choice (at least 6 days stay) from the list of [DOT-accredited quarantine hotels](#).
- On the day of your departure, update your [OneHealthPass/OHP registration](#) (seat number, health declaration, negative pre-departure RT-PCR test result and other details).
 - Input your transaction number and last name. **Save or print the OHP QR code generated** (This is also sent to your e-mail address)
- For unvaccinated non-OFW/foreign travellers only:** Pre-book your post-arrival RT-PCR swab test through your quarantine facility, through online platforms such as [Red Cross electronic Case Investigation Form](#) (e-CIF) or any [DOH-accredited private testing center](#).
- Be ready with a print-out of your **digital vaccination certificate from notarise.gov.sg, (with QR Code)¹/WHO International Certificate of Vaccination (ICV)²"Yellow Card"** and pre-departure negative RT-PCR test result.



While Inflight: Fill out the Arrival Card and Customs Declaration Form provided by the flight attendant.

Upon Arrival

- Proceed to the One-Stop-Shop Holding Area for a briefing on health and safety protocols.
- Present your OHP QR Code at the DOT Help Desk.
- Proceed to the Bureau of Immigration for arrival clearance then to baggage claim and customs inspection.
- Take the accredited or arrange transport service (airport taxi for non-OFWs and foreigners).

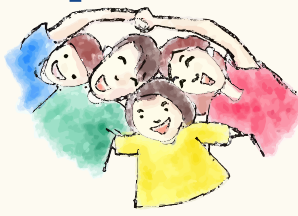

If your post-arrival RT-PCR test result is negative, you will be allowed to check-out of your quarantine facility and spend the remaining days to complete fourteen (14) days of quarantine at home. Present the OHP QR Code upon check-out
<i>Minor travellers below 12 years old (have not turned 12 y/o) who cannot be vaccinated shall follow the quarantine protocols of parent/s or accompanying adult/guardian travelling with them.</i>	

¹ Per IATF Resolution No. 149 series of 2021 dated 18 November 2021, the national COVID-19 vaccination certificate of Singapore or "HealthCerts" (may be obtained via notarise.gov.sg) shall be accepted/recognized for purpose of arrival quarantine protocols as well as interzonal/intrazonal movement.
² Unvaccinated, partially vaccinated, and those whose vaccination status cannot independently confirmed/verified by Philippine authorities

- Self-monitor for any sign or symptom for 7 days.
- Report to the LGU of destination upon the manifestation of symptoms, if any.

a. Fully-Vaxed

- Self-monitor for any sign or symptom for 7 days.
- Report to the LGU of destination upon the manifestation of symptoms, if any.

b. Un-Vaxed/Partially Vaxed

- Proceed to OWWA arrival desk for arrangements of your quarantine facility.
- Undergo facility-based quarantine until the release of your **negative RT-PCR test result.**
 - Conduct of RT-PCR test on the **5th day**
(If you test +, BOQ shall transfer you to a designated hospital)
 - Children below 12yo (have not turned 12yo) who cannot be vaccinated shall follow the quarantine protocols of the parent/s or the accompanying adult/guardian travelling with them.
- Arrange for your own transportation in going home or avail of the OWWA transportation service to your final destination
- Undergo home quarantine until the 14th day, with the date of arrival being the first day

b. Un-Vaxed/Partially Vaxed

- Undergo facility-based quarantine until the release of your **negative RT-PCR test result.**
 - Conduct of RT-PCR test on the **5th day**
(If you test +, BOQ shall transfer you to a designated hospital)
 - Children below 12yo (have not turned 12yo) who cannot be vaccinated shall follow the quarantine protocols of the parent/s or the accompanying adult/guardian travelling with them.
- Arrange for your own transportation in going home.
- Undergo home quarantine until the 14th day, with the date of arrival being the first day
