Application

SPLE applicants are required to submit their applications online through online.prc.gov.ph **until 16 March 2024 only**.

Following the online transaction, applicants must send to the Licensure Division of the PRC (via e-mail at sple@prc.gov.ph), a copy of the duly accomplished Application Form, along with the basic documentary requirements and additional specific documents as enumerated below. The deadline for submission is also on 16 March 2024.

SPLE Proper

Upon arrival at their respective venues of assignment, applicants must present the original of the applicable documents listed below for validation by the PRC Examination Team.

The basic documentary requirements to be submitted by ALL applicants are as follows:

1. Photocopy of Transcript of Records (TOR). TOR without picture or remarks "For Board Exam Purposes" is accepted;
2. Photocopy of Valid Passport; and
3. Two (2) passport size pictures with complete name tag.
