## ADVISORY FOR FILIPINO TRAVELLERS TRANSITING THROUGH SINGAPORE

The Philippine Embassy in Singapore advises all Filipino travellers that the Singapore Government policy for transit through its Changi Airport, as of 3 May 2021, is as follows:

- a) Travellers will be allowed to transit through Singapore Changi Airport if their city of departure is approved for transit flights through Singapore. Please visit <https://www.singaporeair.com/saar5/pdf/media-centre/210503-TableforCitiesApprovedforTransit.pdf>.
- b) Travellers connecting to a city approved for transit flights by Singapore will be allowed to transit through Singapore provided their first country of origin is listed in this link: <https://www.singaporeair.com/saar5/pdf/media-centre/210502ListofBehindCountries.pdf>
- c) Transfers are only allowed between Singapore Airlines, Silk Air and Scoot. Transfers to and from flights operated by other airlines are currently not allowed, except those with which Singapore Airlines has interline agreements such as with Air France and KLM Royal Dutch Airlines, Air Niugini, Garuda Indonesia, Lufthansa, Swiss International Air Lines and Turkish Airlines.
- d) Singapore has unilaterally lifted border restrictions with Australia, Brunei, China, New Zealand, and Taiwan. Passengers transiting through one of these unilaterally opened (UO) countries/regions to connect to a flight to Singapore to reach their final destination, must ensure that they do not originate from or transit through a non-UO country/region prior to entering these UO countries/regions. For example, Fiji – Auckland – Singapore – London is not allowed.
- e) Passengers with a travel history to Bangladesh, India, Nepal, Pakistan and Sri Lanka in the past 21 days will not be allowed to transit through Singapore. Transfers to destinations in Mainland China are currently also not allowed. Singapore Airlines will also stop carrying transit passengers departing from Singapore to Hong Kong due to regulatory requirements. Services from Hong Kong to Singapore remain unaffected, and passengers originating from Hong Kong will be allowed to transfer through Singapore Changi Airport *en route* to their final destinations.

Alternatively, your first point of departure may be from countries listed here, if you are connecting to a city approved for transit flights before transiting through Singapore to your final destination.

\*\*\*\*Singapore has unilaterally lifted border restrictions with Australia; Brunei; China; New Zealand; and Taiwan, China. Do note that passengers transiting through one of these unilaterally opened (UO) countries/regions to connect to a flight to Singapore to reach their final destination, must ensure that they do not originate from or transited through a non-UO country/region prior to entering these UO countries/regions. For example, Fiji – Auckland – Singapore – London is not allowed.
